IAPD offers information on all current-and many former representatives. Investors are strongly encouraged to use IAPD to check the background of representatives before deciding to conduct, or continue to conduct, business with them.

What is included in a IAPD report?

IAPD reports for individual representatives include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards.

It is important to note that the information contained in an IAPD report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the representative, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

Where did this information come from?

The information contained in IAPD comes from the Investment Adviser Registration Depository (IARD) and FINRA's Central Registration Depository, or CRD, (see more on CRD below) and is a combination of:

- information the states require representatives and firms to submit as part of the registration and licensing process, and
- information that state regulators report regarding disciplinary actions or allegations against representatives.

Generally, representatives are required to update their professional and disciplinary information in IARD within 30 days.

Allegations: In September 2014 client invested in a variety of income oriented investments. Complaint alleges representative told the client they would not lose their principal. One of the bonds in the account defaulted. Client decided to sell all the investments in the account resulting in a loss. Client then sent a letter complaining about the bond defaulting and referencing the total loss in the account for all the investments. After receipt of the letter the firm spoke to the client who limited his concerns to the bond that defaulted.

Broker Statement I categorically deny the allegations in the complaint that I stated or even implied that the client not lose their principal investment. Throughout the time the client purchased and held the investments there was consistent communication, including when the bond was declining in value. Only after the bond defaulted did client instruct me to liquidate all holdings, which was against my recommendation. A settlement was reached in order to preserve the overall client relationship as well as avoid uncertainties and costs of continued discussions.
