What is included in a IAPD report?

IAPD reports for individual representatives include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards.

It is important to note that the information contained in an IAPD report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the representative, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

Where did this information come from?

The information contained in IAPD comes from the Investment Adviser Registration Depository (IARD) and FINRA's Central Registration Depository, or CRD, (see more on CRD below) and is a combination of:

- information the states require representatives and firms to submit as part of the registration and licensing process, and
- information that state regulators report regarding disciplinary actions or allegations against representatives.

THE OFFICE FOUND THAT DAVID CHARLES VOSS RENDERED INVESTMENT ADVICE TO PERSONS OF THIS STATE FOR COMPENSATION WITHOUT THE BENEFIT OF LAWFUL REGISTRATION IN THE STATE OF FLORIDA PURSUANT TO SECTION 517.12(4), FLORIDA STATUTES. DAVID CHARLES VOSS AGREED TO PAY AN ADMINISTRATIVE FINE IN THE AMOUNT OF \$5,000. THE OFFICE AGREED TO APPROVE MR. Broker Statement	D C VOSS & COMPANY WAS A FEDERALLY COVERED ADVISOR THAT NOTICE FILED IN FLORIDA FROM APRIL 2008 TO JUNE 2012. IN JUNE 2012 WE BECAME A STATE-REGISTERED ADVISOR AS A RESULT OF THE DODD-FRANK ACT WHICH REQUIRED MEDIUM-SIZE FIRMS TO SWITCH FROM FEDERAL TO STATE REGISTRATION. WE SUCCESSFULLY REGISTERED IN OHIO AND TEXAS AND WITHDREW OUR FEDERAL REGISTRATION. SOMEHOW THE NEED TO REGISTER IN FLORIDA SLIPPED THROUGH THE CRACKS UNTIL MARCH 2013 WHEN WE FILED OUR ANNUAL AMENDMENT AND INCLUDED FLORIDA AS ONE OF THE STATES IN WHICH WE WANTED TO FILE OUR UPDATED FORMS. IN APRIL 2013 WE WERE CONTACTED BY FLORIDA AND BECAME AWARE THAT WE DID NOT SUCCESSFULLY REGISTER IN JUNE 2012. IN NOVEMBER 2013 WE PAID AN ADMINISTRATIVE FINE AND FLORIDA APPROVED OUR APPLICATION FOR REGISTRATION. THERE ARE NO LIMITATIONS ON THE FIRM OR MY ABILITY TO PROVIDE INVESTMENT ADVISORY SERVICES TO FLORIDA RESIDENTS OR ANY OTHER PERSONS.
