What is included in a IAPD report?

IAPD reports for individual representatives include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards.

It is important to note that the information contained in an IAPD report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the representative, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

Where did this information come from?

The information contained in IAPD comes from the Investment Adviser Registration Depository (IARD) and FINRA's Central Registration Depository, or CRD, (see more on CRD below) and is a combination of:

- information the states require representatives and firms to submit as part of the registration and licensing process, and
- information that state regulators report regarding disciplinary actions or allegations against representatives.

Broker Statement AS A RESULT OF CONFUSION IN TRANSITIONING TO A NEW ELECTRONIC REGULATORY FILING PROCESS AND CERTAIN BACK-OFFICE MISTAKES BY HIS OWN FIRM, KEITH HUBER'S REGISTRATION AS INVESTMENT ADVISER REPRESENTATIVE WAS NOT RENEWED IN TEXAS FOR 2002. KEITH HUBER DISCOVERED THE OVERSIGHT IN NOVEMBER 2005. HE REPORTED IT IMMEDIATELY AND FILED FOR REGISTRATION, WHICH WAS GRANTED BY THIS ORDER. NO CUSTOMERS WERE HARMED BY THE OVERSIGHT. NO



CUSTOMER HAS EVER COMPLAINED ABOUT MR. HUBER. KEITH HUBER HAS BEEN REGISTERED CONTINUOUSLY WITH THE NASD AND THE STATE OF TEXAS FROM OCTOBER 1996 TO THE PRESENT, AS A REGISTERED REPRESENTATIVE OF MML INVESTOR SERVICE, INC.
