### Broker Statement

AFTER A THREE DAY HEARING, AN NASDR ARBITRATION PANEL AWARDED THIS FORMER CLIENT \$112,840 IN COMPENSATORY DAMAGES, PLUS \$25,200 IN LEGAL FEES. WE BELIEVE WE PRESENTED CREDIBLE EVIDENCE THAT THE ACTIVITY IN THE ACCOUNT WAS CONSISTENT WITH THE EXPRESSED INVESTMENT OBJECTIVES OF THE CLIENT, THAT THE CLIENT MAINTAINED CONTROL OVER AND MADE ALL INVESTMENT DECISIONS IN THE ACCOUNT AND THAT THE RR RELIED IN GOOD FAITH ON THE CLIENT'S REPRESENTATION THAT THE FUNDS IN THE ACCOUNT WERE HIS PERSONAL MONEY AND THAT HE WAS THE SOLE BENEFICIARY OF THE PLAN. THE LOSSES IN THIS ACCOUNT WERE SUSTAINED AS A RESULT OF HOLDINGS IN SHIVA CORPORATION WHICH PLUMMETED UPON THE ANNOUNCEMENT OF A WRITE-OFF OF INVENTORY AND RESTATEMENT OF EARNINGS. FURTHER, SHIVA SETTLED A CLASS ACTION LAWSUIT WITH SHAREHOLDERS OVER THIS MATTER IN 1999. WE BELIEVE THAT THIS AWARD WAS EXCESSIVE AND AGAINST THE WEIGHT OF THE EVIDENCE.
