What is included in a IAPD report?

IAPD reports for individual representatives include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards.

It is important to note that the information contained in an IAPD report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the representative, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

Where did this information come from?

The information contained in IAPD comes from the Investment Adviser Registration Depository (IARD) and FINRA's Central Registration Depository, or CRD, (see more on CRD below) and is a combination of:

- information the states require representatives and firms to submit as part of the registration and licensing process, and
- information that state regulators report regarding disciplinary actions or allegations against representatives.

Broker Statement

The client's allegations are false and I never received instructions to limit my investment recommendations to only municipal bonds. My recommendation to purchase the preferred stock at issue was suitable for and consistent with the client's stated investment objective and risk tolerance at the time. I consulted with the client prior to purchasing the preferred stock and we reviewed the features of the preferred stock. The client approved and authorized the purchase prior to execution. Further, the client received a trade confirmation memorializing the purchase of the preferred stock on or about April 10, 2014 and received monthly statements for two years prior to his complaint which listed the investment under the category of "Preferreds" rather than "Municipal Bonds." The client later recalled authorizing the purchase. The firm responded to the client denying his allegations. Accordingly, there should be no liability or wrongdoing on my part associated with this complaint.
