IAPD Information About Representatives

IAPD offers information on all current-and many former representatives. Investors are strongly encouraged to use IAPD to check the background of representatives before deciding to conduct, or continue to conduct, business with them.

What is included in a IAPD report?

IAPD reports for individual representatives include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards.

It is important to note that the information contained in an IAPD report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the representative, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

Where did this information come from?

The information contained in IAPD comes from the Investment Adviser Registration Depository (IARD) and FINRA's Central Registration Depository, or CRD, (see more on CRD below) and is a combination of:

- information the states require representatives and firms to submit as part of the registration and licensing process, and
- information that state regulators report regarding disciplinary actions or allegations against representatives.

Generally, representatives are required to update their professional and disciplinary information in IARD within 30 days.

THE TERMS OF THE SETTLEMENT CALL FOR VARIOUS PAYMENTS TO BE MADE TO [CUSTOMER] TOTALING \$85,000. MONTHLY PAYMENTS BEGAN ON 10-15-95 AND ARE EXPECTED TO BE PAID IN FULL BY MAY 15, 1996. SAID PAYMENTS ARE BEING MADE BY CERTAIN DEFENDANTS IN THE CASE OTHER THAN MYSELF. UPON HER RECEIPT OF HER PAYMENT IN FULL (MAY 15, 96) [SPOUSE] HAS AGREED TO RELEASE, ACQUIT AND DISCHARGE ME FROM ANY AND ALL CLAIMS, ACTIONS, DEMAND, OR CAUSE OF ACTION IF ANY. THE NASD INVESTIGATED MY INVOLVEMENT IN THIS MATTER AND DETERMINED THAT NO ACTION AGAINST ME WAS WARRANTED AND CLOSED THE MATTER PERTAINING TO ME. DURING 1990 WHEN I WAS EMPLOYED BY DELTA FIRST FINANCIAL THE PLAINTIFF CONTACTED ME BY TELEPHONE FOR FINANCIAL ADVISE. PLAINTIFF PURCHASED VARIOUS INVESTMENTS OVER A 12 MONTH PERIOD. PLAINTIFF WAS SUITABLE AND NO SECURITIES VIOLATIONS OCCURRED. PLAINTIFF AND ATTORNEY ARE ALLEGING CHARGES WITHOUT SHOWING ANY BASIS OF TRUTH. PLAINTIFF'S INVESTMENTS PERFORMED AS EXPECTED UNTIL RECENTLY WHEN GENERAL PARTNER FELL BEHIND ON DIVIDENDS. THIS PROMPTED PLAINTIFF TO ALLEGE THESE CHARGES FIVE YEARS AFTER THE PURCHASE AGAINST THE GENERAL PARTNERS, OWNERS OF DELTA FIRST, AND ME. THE NASD INVESTIGATED MY INVOLVEMENT IN THIS MATTER AND DETERMINED THAT NO ACTION AGAINST ME WAS WARRANTED AND CLOSED THE MATTER PERTAINING TO ME.
