IAPD Information About Representatives

IAPD offers information on all current-and many former representatives. Investors are strongly encouraged to use IAPD to check the background of representatives before deciding to conduct, or continue to conduct, business with them.

What is included in a IAPD report?

IAPD reports for individual representatives include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards.

It is important to note that the information contained in an IAPD report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the representative, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

Where did this information come from?

The information contained in IAPD comes from the Investment Adviser Registration Depository (IARD) and FINRA's Central Registration Depository, or CRD, (see more on CRD below) and is a combination of:

- information the states require representatives and firms to submit as part of the registration and licensing process, and
- information that state regulators report regarding disciplinary actions or allegations against representatives.

How current is this information?

Generally, representatives are required to update their professional and disciplinary information in IARD within 30 days.

 - A "resolved" matter usually includes a disposition wherein no payment is made to the customer or there is no finding of wrongdoing on the part of the Investment Adviser Representative. Such matters generally involve customer disputes.

Allegations:	In 2010, Ms. Malloy provided investment services to [Customer]. In July 2010 [Customer] chose to invest \$240,000 in Income Opportunity Capital, LLC ("IOC"). A foundation in which [Customer] was involved, which was not a customer of Ms. Malloy, subsequently invested additional funds in IOC through another investment advisor. [Customer] and the Foundation brought actions against both investment advisors. In the lawsuit, filed six years later, they alleged, among other things, that the risks of an investment in IOC were not adequately disclosed.

Broker Statement	[Customer] requested that this investment be made on her behalf. Over the following 6 years she received over \$120,000 in income on her \$240,000 investment. Risks of the investment were identified in the documents she signed. [Customer] also helps operate a separate foundation which made further investments in IOC through a different advisor. Ms. Malloy had no involvement with that investment and the Foundation was not a customer. The lawsuit brought claims on behalf of the Foundation and [Customer]. The parties worked toward an early mediation to bring it to resolution. During the mediation process it was agreed that the only claims against Ms. Malloy were those of [Customer]. Because of the cost of further litigation, M Capital paid \$10,000 toward settlement and Ms. Malloy paid nothing.
