MERRILL LYNCH'S INVESTIGATION DETERMINED THAT MS. HODGES ENGAGED IN NO WRONGDOING. THE ACCOUNTS IN QUESTION WERE REVIEWED BY MANAGEMENT THROUGH REGULAR ACTIVITY REVIEWS AND IT WAS DETERMINED THAT THE TRANSACTIONS AT ISSUE WERE EITHER UNSOLICITED OR ORIGINATED WITH THE [CUSTOMERS] OWN INVESTMENT IDEAS. THE USE OF MARGIN WAS KNOWN TO AND WAS INITIATED BY THE [CUSTOMERS]. OUR INVESTIGATION ALSO REVEALED THAT THE [CUSTOMERS] HAD A LONG HISTORY OF AGGRESSIVE INVESTMENTS OUTSIDE OF MS, INCLUDING A FAILED AFRICAN MINERAL RIGHTS VENTURE OWNED BY [CUSTOMER] WHICH RESULTED IN SUSTANTIAL LOSSES. IN VIEW OF THESE FACTS, THE MATTER WAS SETTLED FOR A NOMINAL SUM SOLELY TO AVOID THE COSTS AND UNCERTAINTIES OF CONTINUED LITIGATION.
