IAPD offers information on all current-and many former representatives. Investors are strongly encouraged to use IAPD to check the background of representatives before deciding to conduct, or continue to conduct, business with them.

What is included in a IAPD report?

IAPD reports for individual representatives include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards.

It is important to note that the information contained in an IAPD report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the representative, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

Where did this information come from?

The information contained in IAPD comes from the Investment Adviser Registration Depository (IARD) and FINRA's Central Registration Depository, or CRD, (see more on CRD below) and is a combination of:

- information the states require representatives and firms to submit as part of the registration and licensing process, and
- information that state regulators report regarding disciplinary actions or allegations against representatives.

Generally, representatives are required to update their professional and disciplinary information in IARD within 30 days.

In the context of an extended interfamilial dispute, plaintiff alleges that the erroneous form resulted in the decedent's nephew improperly receiving the account holder's assets upon his death rather than the estate of the account holder's sister.

Broker Statement On July 17, 2019 the Rhode Island Superior Court entered judgement, verifying the jury's award of \$5,414,211 against the decedent's nephew, Financial Advisor and his employer. Subsequent to post trial motions, this matter was voluntarily settled with the plaintiffs for \$650,000 on April 24, 2020. Although both the Financial Advisor and Firm continue to deny the allegations, the matter was resolved to mitigate the costs associated with continued civil litigation.
