What is included in a IAPD report?

IAPD reports for individual representatives include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards.

It is important to note that the information contained in an IAPD report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the representative, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

Where did this information come from?

The information contained in IAPD comes from the Investment Adviser Registration Depository (IARD) and FINRA's Central Registration Depository, or CRD, (see more on CRD below) and is a combination of:

- information the states require representatives and firms to submit as part of the registration and licensing process, and
- information that state regulators report regarding disciplinary actions or allegations against representatives.

Generally, representatives are required to update their professional and disciplinary information in IARD within 30 days.

ON OR ABOUT FEBRUARY 19, 2008, JENSEN MADE A TRADE IN HIS PERSONAL ACCOUNT, IN VIOLATION OF THE POLICIES SET FORTH IN THE RBC WEALTH MANAGEMENT COMPLIANCE MANUAL, WHICH RESULTED IN AN UNSECURED DEBIT IN EXCESS OF FIVE HUNDRED FIFTY THOUSAND DOLLARS (\$550,000.00)

AT SEVERAL TIMES DURING FEBRUARY 2008, JENSEN DEPOSITED CHECKS INTO HIS PERSONAL RBC ACCOUNT FOR WHICH THERE WERE INSUFFICIENT FUNDS TO COVER AT THE TIME THEY WERE DEPOSITED. ALTHOUGH JENSEN WIRED SUFFICIENT FUNDS INTO HIS ACCOUNT TO COVER THE AMOUNTS OF THE CHECKS DEPOSITED AFTER RECEIVING NOTICE THAT CHECKS HAD BEEN RETURNED NSF, HE WROTE CHECKS AGAINST HIS PERSONAL RBC ACCOUNT, WHICH WERE RETURNED BY RBC DUE TO INSUFFICIENT FUNDS .
