What is included in a IAPD report?

IAPD reports for individual representatives include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards.

It is important to note that the information contained in an IAPD report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the representative, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

Where did this information come from?

The information contained in IAPD comes from the Investment Adviser Registration Depository (IARD) and FINRA's Central Registration Depository, or CRD, (see more on CRD below) and is a combination of:

- information the states require representatives and firms to submit as part of the registration and licensing process, and
- information that state regulators report regarding disciplinary actions or allegations against representatives.

The initiative seeks to fund, acquire, and operate a night-capable Type 1 firefighting helicopter that can respond immediately to wildfire ignitions, medical emergencies, and search-and-rescue incidents throughout the region. The program is designed to dramatically reduce wildfire risk by enabling rapid initial attack during the critical first minutes of a fire, when suppression efforts are most effective. In furtherance of this purpose, the nonprofit corporation will support the planning, funding, development, and construction of a permanent helitack base and related operational infrastructure within the Lake Tahoe Basin to house and maintain a firefighting helicopter and crew on standby for rapid response. I will serve on the board to assist in oversight of the project.
