CLAIM WITHDRAWN by Claimant. As indicated in the original disclosure when the Statement of Claim was filed, Claimant cherry-picked an investment (NorthStar) that did not perform as expected and claimed that it was not suitable and that the broker-dealer failed to do its due diligence. The statement of claim is a cookie-cutter that makes clearly false claims and accusations about the representative's conduct and statements. In addition, it fails to acknowledge that the investment was part of an overall plan/strategy. The Firm's initial investigation did not reveal any information to support the claims made and, prior to withdrawal, the firm had been defending the action as without merit. Characteristics, features and risks of the product(s) were fully disclosed at the time of the recommendations and were in line with Claimant's stated investment objectives, risk tolerance and time horizon.
