<b>Broker Statement</b>	<p>In April 2006, I inherited the relationship of a client whose former financial advisor had left the firm. The inherited client came to me with a highly concentrated stock position in his account, which I strongly advised he diversify and asset allocate. Unfortunately, he declined my repeated recommendations to do so. The stock, Washington Mutual, went bankrupt during the 2008 Financial Crisis resulting in a total loss to the client. As my name was the last on the client's account statements, I was brought into this arbitration unfairly. I maintain, despite the settlement in this case, that I had no liability in this matter and there was no wrongdoing on my part. This stock was all purchased by another broker and I repeatedly tried to get the client to diversify.</p>
