IAPD offers information on all current-and many former representatives. Investors are strongly encouraged to use IAPD to check the background of representatives before deciding to conduct, or continue to conduct, business with them.

What is included in a IAPD report?

IAPD reports for individual representatives include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards.

It is important to note that the information contained in an IAPD report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the representative, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

Where did this information come from?

The information contained in IAPD comes from the Investment Adviser Registration Depository (IARD) and FINRA's Central Registration Depository, or CRD, (see more on CRD below) and is a combination of:

- information the states require representatives and firms to submit as part of the registration and licensing process, and
- information that state regulators report regarding disciplinary actions or allegations against representatives.

Generally, representatives are required to update their professional and disciplinary information in IARD within 30 days.

Disclosure Information

Allegations: CLIENTS STATE LAMARR LACKS SUFFICIENT FINANCIAL EXPERTISE WITH WHICH TO HANDLE THEIR INVESTMENTS. CLIENTS ARE UNHAPPY WITH THE PERFORMANCE OF THEIR MUTUAL FUNDS THEY PURCHASED IN MAY 2000 AND STATE LAMARR SHOULD HAVE "EXPLAINED A LITTLE FURTHER IN DEPTH" MUTUAL FUNDS. THE CLIENTS STATE THEIR FUNDS HAVE DECLINED IN VALUE IN EXCESS OF \$5,000. CLIENTS ALSO STATE THEY INFORMED LAMARR THEY WOULD NEED \$60,000 OF THE 401K ASSETS IN A SHORT PERIOD OF TIME TO PAY BILLS; THE FUNDS WERE PLACED IN AN IRA. THE CLIENTS QUESTION THIS AS THE FUNDS WERE EARMARKED TO REPAY DEBT AND THEY WILL INCUR \$7100 IN PENALTIES FOR AN EARLY DISTRIBUTION.
