What is included in a IAPD report?

IAPD reports for individual representatives include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards.

It is important to note that the information contained in an IAPD report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the representative, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

Where did this information come from?

Allegations: Without admitting or denying the findings, Romjue consented to the sanctions and to the entry of findings that he caused his member firm to maintain inaccurate books and records by changing the representative code for trades, causing the trade confirmations to show an inaccurate representative code. The findings stated that Romjue entered into an agreement through which he agreed to service certain customer accounts, including executing trades for those accounts, under a joint representative code that he shared with a retired representative. Romjue later entered into a separate agreement through which he agreed to service additional customer accounts, including executing trades for those accounts, under a joint representative code that he shared with a second retired representative. Each agreement set forth what percentages of the commissions each representative would earn on trades placed using the applicable joint representative code. Although the firm's system correctly prepopulated the trades with the applicable joint representative code, Romjue changed the codes for the trades to his personal representative code or another representative code. Romjue did not ask either retired representative whether he could change the code on the trades and did not



otherwise indicate to them that he was doing so. Instead, Romjue incorrectly assumed that the retired representatives agreed with his changing the codes because they did not complain about the commissions they received during this time period. Romjue's actions resulted in his receiving higher commissions from the trades than what he was entitled to receive. Romjue's firm later paid restitution to the retired representatives. Romjue reimbursed the firm \$182,232, which is the approximate amount of additional commissions that he received from the trades as a result of his falsifying the representative code on the trades.
