What is included in a IAPD report?

IAPD reports for individual representatives include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards.

It is important to note that the information contained in an IAPD report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the representative, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

Where did this information come from?

The information contained in IAPD comes from the Investment Adviser Registration Depository (IARD) and FINRA's Central Registration Depository, or CRD, (see more on CRD below) and is a combination of:

- information the states require representatives and firms to submit as part of the registration and licensing process, and
- information that state regulators report regarding disciplinary actions or allegations against representatives.

 - A "resolved" matter usually includes a disposition wherein no payment is made to the customer or there is no finding of wrongdoing on the part of the Investment Adviser Representative. Such matters generally involve customer disputes.

Allegations: CUSTOMER FEELS THAT PURCHASES MADE THROUGH MR. JONES WERE UNSUITABLE GIVEN HIS AGE AND HIS RISK TOLERANCE. CLIENT ALLEGES THAT MR. JONES PURCHASED CERTAIN BONDS IN 1999 THAT WERE NOT SUITABLE TO CUSTOMER'S RISK. CUSTOMER FURTHER ALLEGES THAT HE DID NOT KNOW WHAT THESE BONDS WERE OR THAT HE "NEVER TOLD MR. JONES TO BUY JUNK BONDS". THE FIRM HAS REVIEWED THE ALLEGATIONS AND HAS FOUND THAT AT THE TIME CUSTOMER PURCHASED THE BONDS IN QUESTION, THEY WERE INVESTMENT GRADE QUALITY. ADDITIONALLY, CUSTOMER WAS AWARE OF THE BONDS HE WAS PURCHASING AND RECEIVED CONFIRMATIONS THAT DESCRIBED THE PURCHASES. ADDITIONALLY, CUSTOMER RECEIVED MONTHLY STATEMENTS THAT INDICATED THE BONDS PURCHASED AND THE CURRENT MARKET VALUE. THE BONDS CONTINUE TO MAKE THEIR SCHEDULED INTEREST PAYMENTS AND CUSTOMER WILL RECEIVE THE FULL PRINCIPAL AMOUNT SHOULD HE HOLD THE BONDS TO MATURITY. THE FIRM WILL NOT BE ADJUSTING THE CUSTOMER'S ACCOUNT.
