What is included in a IAPD report?

IAPD reports for individual representatives include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards.

It is important to note that the information contained in an IAPD report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the representative, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

Where did this information come from?

The information contained in IAPD comes from the Investment Adviser Registration Depository (IARD) and FINRA's Central Registration Depository, or CRD, (see more on CRD below) and is a combination of:

- information the states require representatives and firms to submit as part of the registration and licensing process, and
- information that state regulators report regarding disciplinary actions or allegations against representatives.

Generally, representatives are required to update their professional and disciplinary information in IARD within 30 days.

Allegations: CUSTOMER ALLEGES THAT HE WAS NOT PROVIDED WITH DESIRED SERVICE ON HIS VARIABLE ANNUITY CONTRACT, WHICH HE HAD PURCHASED IN AUGUST 2004. CUSTOMER ALSO ALLEGED THAT REP HAD ADVISED HIM THAT IF HIS EXPECTATIONS WERE NOT MET, HE COULD SURRENDER THE CONTRACT WITHOUT IMPOSITION OF ANY SURRENDER FEES. REP DENIES ALL CLAIMS AND ALLEGATIONS, AND STATES THAT HE PROVIDED COMPLETE AND ACCURATE INFORMATION CONCERNING VARIABLE ANNUITY PRODUCT TO CLIENT, BOTH VERBALLY AND IN WRITING, WHICH INFORMATION INCLUDED THE ASSOCIATED SURRENDER CHARGES FOR EARLY WITHDRAWAL, BEFORE CLIENT MADE ANY INVESTMENT DECISION. REP. FURTHER STATES THAT HE PROVIDED ONGOING SERVICE TO CLIENT AND ATTEMPTED TO BE RESPONSIVE AT ALL TIMES, BUT THAT CLIENT WAS ATTEMPTING TO HAVE REP TIME THE MARKET AND GUARANTEE RETURNS, WHICH REP WOULD NOT DO.
