IAPD Information About Representatives

IAPD offers information on all current-and many former representatives. Investors are strongly encouraged to use IAPD to check the background of representatives before deciding to conduct, or continue to conduct, business with them.

What is included in a IAPD report?

IAPD reports for individual representatives include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards.

It is important to note that the information contained in an IAPD report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the representative, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

Where did this information come from?

The information contained in IAPD comes from the Investment Adviser Registration Depository (IARD) and FINRA's Central Registration Depository, or CRD, (see more on CRD below) and is a combination of:

- information the states require representatives and firms to submit as part of the registration and licensing process, and
- information that state regulators report regarding disciplinary actions or allegations against representatives.

How current is this information?

Generally, representatives are required to update their professional and disciplinary information in IARD within 30 days.

MY FORMER EMPLOYER AMENDED MY FORM U-5 ON MAY 15, 2009 TO REPORT THE DENIAL OF THIS "COMPLAINT". THE "COMPLAINT" AT ISSUE WAS ACTUALLY WITHDRAWN BY THE CLIENT ON NOVEMBER 9, 2008 BY LETTER. SUBSEQUENTLY, ON APRIL 2, 2009 CITIGROUP GLOBAL MARKETS INC. ISSUED A DENIAL LETTER BUT DID NOT AMEND MY CRD RECORD TO REFLECT THAT THIS MATTER WAS WITHDRAWN IN NOVEMBER 2008 WHILE I WAS STILL EMPLOYED THERE, OR DENIED ON APRIL 2, 2009, 8 DAYS AFTER MY RESIGNATION. INSTEAD, THIS MATTER REMAINED OPEN ON MY CRD RECORD, WHILE CITIGROUP PURSUED LITIGATION AGAINST ME, DESPITE REPEATED REQUESTS BY MY ATTORNEY TO CITIGROUP TO UPDATE MY CRD RECORD. AS A RESULT OF THESE UNJUSTIFIED DELAYS, THE STATE OF ARIZONA CONCLUDED THAT I HAD AN UNRESOLVED COMPLAINT ON MY CRD RECORD AND DELAYED APPROVAL OF MY APPLICATION FOR REGISTRATION IN THEIR STATE UNTIL JUNE 10, 2009.
