ACCORDING TO THE BRANCH OFFICE ADMINISTRATOR THE CONFIRMATIONS AND PROSPECTUSES WERE MAILED TO THE ADDRESS OF RECORD DIRECTLY FROM THE BRANCH. IT HAS BEEN VERIFIED THAT THE QUARTERLY STATEMENTS WERE MAILED TO THE ADDRESS OF RECORD DIRECTLY FROM AMERICAN FUNDS.
