IAPD Information About Representatives

IAPD offers information on all current-and many former representatives. Investors are strongly encouraged to use IAPD to check the background of representatives before deciding to conduct, or continue to conduct, business with them.

What is included in a IAPD report?

IAPD reports for individual representatives include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards.

It is important to note that the information contained in an IAPD report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the representative, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

Where did this information come from?

The information contained in IAPD comes from the Investment Adviser Registration Depository (IARD) and FINRA's Central Registration Depository, or CRD, (see more on CRD below) and is a combination of:

- information the states require representatives and firms to submit as part of the registration and licensing process, and
- information that state regulators report regarding disciplinary actions or allegations against representatives.

How current is this information?

Generally, representatives are required to update their professional and disciplinary information in IARD within 30 days.

 - A "settled" matter generally represents a disposition wherein the parties involved in a dispute reach an agreement to resolve the matter. Please note that Investment Adviser Representatives and firms may choose to settle customer disputes or regulatory matters for business or other reasons.
 - A "resolved" matter usually includes a disposition wherein no payment is made to the customer or there is no finding of wrongdoing on the part of the Investment Adviser Representative. Such matters generally involve customer disputes.

Broker Statement	THE COMPANY, FFP SECURITIES, SAID THERE WAS A 4-DAY SUSPENSION, WHEN IN REALITY I HAD ALREADY QUIT THE COMPANY. THE BRANCH MANAGER, CRAIG RANDALL, HAD INSTRUCTED ME TO CONTACT THE CLIENT WITH A LETTER, WHICH I DID, THEN PUT ME ON RESTRICTED FOR THIS, WITH MR. RANDALL CLAIMING NO PART. AT THE SAME TIME, THE COMPANY TOLD ME THEY HAD FOUND NO BASIS TO HER CLAIM, AND THERE WAS NO NEED TO WORRY SINCE I HAD BEEN CLEARED. I FELT THE MANNER IN WHICH FFP SECURITIES HANDLED THIS MATTER WAS VERY UNFAIR TO ME. THEY TOLD ME THEY HAD FOUND NO BASIS FOR THE CUSTOMER'S COMPLAINT, YET THEY HAD SUSPENDED ME FOR SENDING A LETTER THAT I WAS INSTRUCTED TO DO BY THE BRANCH MANAGER, CRAIG RANDALL. THEN THEY TOLD ME THE WHOLE INVESTIGATION MATTER HAD BEEN COMPLETED WITH THE SEC WITH NO BASIS FOR HER ALLEGATIONS. THE COMPANY WAS NOT TRUTHFUL WITH ME IN ANY WAY REGARDING THE ISSUE, ITS OUTCOME, AND MY INSTRUCTED COURSE OF ACTION DURING THE WHOLE THING.
