IAPD offers information on all current-and many former representatives. Investors are strongly encouraged to use IAPD to check the background of representatives before deciding to conduct, or continue to conduct, business with them.

What is included in a IAPD report?

IAPD reports for individual representatives include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards.

It is important to note that the information contained in an IAPD report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the representative, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

Where did this information come from?

The information contained in IAPD comes from the Investment Adviser Registration Depository (IARD) and FINRA's Central Registration Depository, or CRD, (see more on CRD below) and is a combination of:

- information the states require representatives and firms to submit as part of the registration and licensing process, and
- information that state regulators report regarding disciplinary actions or allegations against representatives.

How current is this information?

Generally, representatives are required to update their professional and disciplinary information in IARD within 30 days.

This section provides information regarding a customer dispute that was reported to the Investment Adviser Registration Depository (IARD) by the Investment Adviser Representative (IAR), an investment adviser and/or securities firm, and/or a securities regulator. Employing firm when activities occurred which led to the complaint: MH MEYERSON & CO., INC

Allegations: A FELLOW TEAM MEMBER WAS UNEXPECTEDLY HOSPITALIZED AND I WAS ASSIGNED ONE OF HIS CLIENTS. THE CLIENT WAS A VERY ACTIVE DAY TRADER WHOSE ACCOUNT WAS CLOSELY MONITORED BY THE COMPLIANCE DEPARTMENT BECAUSE OF THE LARGE MARGIN ACCOUNT AND NUMEROUS LONG AND SHORT POSITIONS HELD ON ANY GIVEN DAY. THE CLIENT LOST MONEY ON AN EQUITY POSITION AND OWED THE FIRM APPROXIMATELY \$2,750 FOR A DEBIT IN HIS ACCOUNT. HE CALLED OUR NATIONAL SALES MANAGER, ERIC LOGIN AND COMPLAINED ABOUT THE COMMISSION CHARGED ASSOCIATED WITH THAT SPECIFIC TRADE. THE COMMISSION WAS IN-LINE WITH THE ACCOUNTS LONG-TERM HISTORY WITH THE FIRM. THE FOLLOWING WEEK HE COMPLAINED THE SAME TRADE WAS UNAUTHORIZED TO THE SAME MANAGER AND WANTED TO FILE A COMPLAINT. THE MANAGEMENT AS WELL AS COMPLIANCE SUGGESTED THAT THEY WOULD PAY THE CLIENT ABOUT \$12,000 AND I WOULD COVER THE DEBIT IN THE ACCOUNT. THEY SAID LAWYER FEES AND OTHER RELATED COSTS WOULD BE GREATER THEN THE COST OF THE DEBIT. I RECEIVED A LETTER FROM THE NASD ON FEBRUARY 14, 2000, WHICH STATES THAT A VIOLATION OF SECURITIES REGULATION DID NOT OCCUR.
