What is included in a IAPD report?

IAPD reports for individual representatives include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards.

It is important to note that the information contained in an IAPD report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the representative, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

Where did this information come from?

The information contained in IAPD comes from the Investment Adviser Registration Depository (IARD) and FINRA's Central Registration Depository, or CRD, (see more on CRD below) and is a combination of:

- information the states require representatives and firms to submit as part of the registration and licensing process, and
- information that state regulators report regarding disciplinary actions or allegations against representatives.

Broker Statement

The affiliate insurance company investigated the matter and concluded that the RR met with the clients in person and assisted them in completing the fixed life insurance electronic application. The RR confirmed their intent by asking to see their driver's licenses and input the appropriate information into the electronic application. She asked them to read the information confirming they wanted her to submit the application, at which point the RR thought she had the client's permission to click the signature button on the electronic application to complete the application process.

After submitting, they discussed the need to procure an oral swab specimen for underwriting the policy. It was at this point they decided to withdraw the application. The RR immediately printed off the submission page and asked for a written signature withdrawing the application. This was submitted electronically to the home office and the fixed life insurance application was stopped from processing. No premiums were charged or paid.
