ON MAY 10, 1989, THE FOLLOWING WAS ORDERED: 1. THE REGISTRATION AS AGENT OF DIETRICH WAS SUMMARILY SUSPENDED PURSUANT TO SECTION 204(C) OF M.G.L. C.11A PENDING DETERMINATION BY THE HEARING OFFICER 2. A TEMPORARY CEASE AND DESIST ORDER WAS ENTERED AGAINST DIETRICH, PROHIBITING HIM FROM ENGAGING IN THE SECURITIES BUSINESS WITHIN THE COMMONWEALTH OF MASSACHUSETTS UNTIL FURTHER ORDER OF THE DIRECTOR; 3. DIETRICH WAS TEMPORARILY ORDERED TO CEASE AND DESIST FROM VIOLATING M.G.L. C.110A UNTIL FURTHER ORDER OF THE DIRECTOR.

THE MASSACHUSETTS SECURITIES DIVISION ENTERED A CONSENT ORDER WITH FRANCIS DIETRICH ON DECEMBER 5, 1989. THE ORDER FOUND THAT DIETRICH ALLOWED AN UNREGISTERED AGENT TO TRADE UNDER HIS AGENT NUMBER. DIETRICH WILL PAY A FINE OF \$500.00 AND IS ORDERED TO CEASE AND DESIST FROM VIOLATING M.G.L. C. 110A IN THE FUTURE.

GOOD CAUSE WAS SHOWN NOT TO DISQUALIFY DIETRICH FROM THE PRIVATE PLACEMENT EXEMPTIONS. THE SUMMARY SUSPENSION OF DIETRICH'S REGISTRATION WAS VACATED ON 12/5/89.
