IAPD offers information on all current-and many former representatives. Investors are strongly encouraged to use IAPD to check the background of representatives before deciding to conduct, or continue to conduct, business with them.

What is included in a IAPD report?

IAPD reports for individual representatives include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards.

It is important to note that the information contained in an IAPD report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the representative, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

Where did this information come from?

The information contained in IAPD comes from the Investment Adviser Registration Depository (IARD) and FINRA's Central Registration Depository, or CRD, (see more on CRD below) and is a combination of:

- information the states require representatives and firms to submit as part of the registration and licensing process, and
- information that state regulators report regarding disciplinary actions or allegations against representatives.

Broker Statement I TAKE SERIOUS EXCEPTION TO SEVERAL STATEMENTS CONTAINED IN THE COMPLAINT THAT RELATE TO ME PERSONALLY. PRINCIPAL RISKS ASSOCIATED WITH THE SUBJECT FUND WERE APPROPRIATELY DISCLOSED TO THE CUSTOMER. I RECOMMENDED IT FOR ONE REASON. AMONG ALL THE OPTIONS THAT WERE AVAILABLE TO US WITHIN THE



FUND'S ALLOCATION CATEGORY, I BELIEVED IT WOULD YIELD THE BEST RESULT FOR THE CUSTOMER. I HAD NO INCENTIVE TO DO ANYTHING ELSE. I RECEIVED NO ADDED OR SPECIAL COMPENSATION AS A RESULT OF THE CUSTOMER'S INVESTMENT IN THIS PARTICULAR FUND. I STRONGLY DENY ANY WRONGDOING IN THE MATTER.

Broker Statement THERE WERE NO FINES, PENALTIES, OR SANCTION OF ANY KIND LEVIED AGAINST ME AS MY POSITION IN THE PROCEEDING WAS VALIDATED IN COURT. THE SETTLEMENT REACHED 6/15/87 ALLOWED ME TO RETAIN ALL PROPERTY I HAD BEEN WRONGFULLY ACCUSED OF HAVING WRONGFULLY TAKEN FROM HHP. I WAS FURTHER GRANTED 100% OWNERSHIP OF NSH SUBJECT TO A 2-YEAR FEE SPLITTING AGREEMENT. THE FEE-SPLITTING ARRANGEMENT WAS LIMITED TO TRANSACTIONS IN PROGRESS AT THAT TIME AND TO ANY TRANSACTION INITIATED WITHIN A 2-YEAR PERIOD INVOLVING PRINCIPALS I HAD MET DURING MY TENURE WITH HHP. I WAS TERMINATED FROM HHP BECAUSE I REFUSED TO SIGN AN AGREEMENT THAT WOULD HAVE ALLOWED THE PRESIDENT OF HHP TO TAKE MY 50% INTEREST IN NSH, A SEPARATE BUT AFFILIATED REAL ESTATE/MORTGAGE BROKERAGE FIRM. I HAD FOUNDED NSH AND I HAD DONE SUBSTANTIALLY ALL OF THE WORK REQUIRED TO PUT THE FIRM INTO BUSINESS. AS NOTED ABOVE, MY POSITION WAS VALIDATED IN COURT AND A SETTLEMENT IN MY FAVOR WAS REACHED ON 6/15/87.
