What is included in a IAPD report?

IAPD reports for individual representatives include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards.

It is important to note that the information contained in an IAPD report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the representative, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

Where did this information come from?

The information contained in IAPD comes from the Investment Adviser Registration Depository (IARD) and FINRA's Central Registration Depository, or CRD, (see more on CRD below) and is a combination of:

- information the states require representatives and firms to submit as part of the registration and licensing process, and
- information that state regulators report regarding disciplinary actions or allegations against representatives.

Allegations: CLIENT CLAIMS THAT THE 7/21/98 SELL ORDERS FOR IDAHO PWR, MONTANA PWR, PACIFIC CORP AND WASHINGTON WATER PWR WERE SOLD WITHOUT HIS AUTHORIZATION. \$42,000 OF ICA WAS PURCHASED WITH THE PROCEEDS. HE WANTS TO CANCEL THE MUTUAL FUND PURCHASE AND REPURCHASE THE ELECTRIC POWER STOCKS. HE CLAIMS THE IR CHARGED HIM APPROX. \$5,000 IN COMMISSION FOR THE SELL TRANSACTIONS. HE ALSO CLAIMS HE PURCHASED \$293,000 WORTH OF BONDS. HE CLAIMS THE IR HAS BEEN COLLECTING INTEREST ON THESE BONDS AND HAS REQUESTED THAT THE BONDS BE RETURNED TO HIM.
