What is included in a IAPD report?

IAPD reports for individual representatives include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards.

It is important to note that the information contained in an IAPD report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the representative, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

Where did this information come from?

The information contained in IAPD comes from the Investment Adviser Registration Depository (IARD) and FINRA's Central Registration Depository, or CRD, (see more on CRD below) and is a combination of:

- information the states require representatives and firms to submit as part of the registration and licensing process, and
- information that state regulators report regarding disciplinary actions or allegations against representatives.

Generally, representatives are required to update their professional and disciplinary information in IARD within 30 days.

Regulator Statement	On February 27, 2015, the Office of Financial Regulation entered a Final Order against Raymond L. Johnson, Jr., for engaging in prohibited business practices by failing to accurately disclose written investment advisory contracts, send clients itemized invoices. Raymond L. Johnson, Jr. agreed to pay an administrative fine of \$5,000 jointly and severally with Steadfast Financial Services, Inc.

Allegations: PLAINTIFFS ALLEGED A VIOLATION OF THE FLORIDA SECURITIES AND INVESTOR PROTECTION ACT, SPECICALLY SECTION 517 OF TEH ACT. THE ALLEGATIONS AROSE OUT OF THE EMBEZZLEMENT BY JIM UNDERWOOD, A FORMER EMPLOYEE OF RONALD BLUE & CO., OF FUNDS DEPOSITED INTO INVESTMENT ACCOUNTS BY THE INVESTORS. JIM UNDERWOOD COMMITTED SUICIDE ON AUGUST 8, 1997. THE PLAINTIFFS INSTITUTED THE ACTION AGAINST RONALD BLUE & CO, AND I WAS NAMED A DEFENDANT IN THE SUIT BECAUSE I WAS THE CLIENT MANAGER ON THE ACCOUNTS.
