What is included in a IAPD report?

ON 12/2/08, CFS RECEIVED A WRITTEN COMPLAINT FROM THE CLIENTS ALLEGING THAT ON 1/22/08 THEY HAD INSTRUCTED THEIR CFS REPRESENTATIVE TO REALLOCATE THEIR VARIABLE ANNUITY'S SUBACCOUNTS TO MONEY MARKET. THE 12/2/08 COMPLAINT LETTER WAS THE FIRST NOTIFICATION CFS RECEIVED THAT THE REALLOCATION WAS NOT PROCESSED, AS ALLEGEDLY INSTRUCTED, AND REQUESTED



COMPENSATION FOR THE MARKET LOSS INCURRED IN THE VARIABLE ANNUITY SINCE 1/22/08. CFS HAS REVIEWED THIS MATTER AND FOUND NO EVIDENCE TO SUPPORT THAT INSTRUCTIONS WERE GIVEN BY THE CLIENTS TO REALLOCATE ON 1/22/08. CFS BELIEVES THAT THE CLIENTS WERE ADEQUATELY NOTIFIED OF THEIR CONTACT'S SUBACCOUNT COMPOSITION THROUGH THE THREE QUARTERLY ACCOUNT STATEMENTS SENT TO THE CLIENTS BY THE ANNUITY COMPANY AFTER THE DATE OF THEIR ALLEGED REQUEST. CFS DENIED THIS COMPLAINT IN WRITING ON 12/31/08 BASED UPON A REVIEW OF ALL AVAILABLE INFORMATION, INCLUDING THE COMPLAINT RESPONSE PROVIDED BY THE CFS REPRESENTATIVE.
