THIS MATTER INVOLVES THE SALE OF AUCTION RATE SECURITIES (ARS). THE TRANSACTION(S) AT ISSUE TOOK PLACE BEFORE MID-FEBRUARY 2008, WHEN THE ARS MARKET SUFFERED WIDESPREAD AUCTION FAILURES AND ILLIQUIDITY. THE FINANCIAL ADVISOR DID NOT CAUSE, CONTRIBUTE OR HAVE ANY CONTROL WHATSOEVER OVER THESE MARKET EVENTS. FA STATES THAT [CUSTOMER] TRANSFERRED \$750,000 IN ARPS TO OUR FIRM FROM ANOTHER FIRM. HE CONTINUED TO PURCHASE ARPS FROM OUR FIRM AND HAD \$450,000 IN ARPS AT THE TIME THE MARKET FROZE. ADDITIONALLY, THE FINANCIAL ADVISOR HAD RECOMMENDED TO [CUSTOMER] THAT HE BUY 3-YEAR CDS. HOWEVER, THE CLIENT CHOSE NOT TO PURCHASE THE CDS, BECAUSE HE PREFERRED TO CONTINUE INVESTING IN ARPS. THE FIRM REACHED AGREEMENT WITH CERTAIN OF ITS REGULATORS, PURSUANT TO WHICH IT REPURCHASED ARS FOR THEIR FULL PAR VALUE FROM CERTAIN CLIENTS, INCLUDING THE INSTANT CLIENT, WHETHER THEY COMPLAINED OR NOT. THE FINANCIAL ADVISOR WAS NOT A PARTY TO THAT AGREEMENT, DID NOT MAKE ANY PAYMENTS TO THE CLIENT, AND WAS NOT ASKED TO AND DID NOT CONTRIBUTE THE REPURCHASE AMOUNT. THE SETTLEMENT AMOUNT IN ITEM 11 ABOVE REFLECTS THE PAR VALUE OF THE REPURCHASED ARS, AS REQUIRED BY FINRA REGULATORY NOTICE 09-12.
