IAPD offers information on all current-and many former representatives. Investors are strongly encouraged to use IAPD to check the background of representatives before deciding to conduct, or continue to conduct, business with them.

What is included in a IAPD report?

IAPD reports for individual representatives include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards.

It is important to note that the information contained in an IAPD report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the representative, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

Where did this information come from?

The information contained in IAPD comes from the Investment Adviser Registration Depository (IARD) and FINRA's Central Registration Depository, or CRD, (see more on CRD below) and is a combination of:

- information the states require representatives and firms to submit as part of the registration and licensing process, and
- information that state regulators report regarding disciplinary actions or allegations against representatives.

Generally, representatives are required to update their professional and disciplinary information in IARD within 30 days.

THE CLIENT STATES AT THE SAME TIME HE INSTRUCTED THE BRANCH TO PURCHASE 2000 SHARES OF ABHH. THE CLIENT STATES ON 4/21/99, WHILE THE IR WAS REQUESTING PAYMENT FOR THE ABHH PURCHASE, THE CLIENT WAS INFORMED THAT THE SELL OF FNCM WAS NEVER PLACED. THE CLIENT REQUEST THE SELL PRICE OF 18 1/8.

OVER THE PHONE, AT WHICH TIME, THE CLIENT INDICATED HE BELIEVED THE PRICE WOULD INCREASE AND HE WOULD WAIT TO LIQUIDATE THE SHARES. THE IR STATES THE CLIENT WAS AWARE THE FNCM HAD NOT BEEN SOLD AT THE TIME HE PURCHASED ABHH. CHECKS FOR THESE TRADES WERE RETURNED FOR INSUFFICIENT FUNDS. AS A RESULT, THE STOCKS WERE SOLD RESULTING IN A DEBIT BALANCE OF \$9875 IN THE CUSTOMERS ACCOUNT.
