- information the states require representatives and firms to submit as part of the registration and licensing process, and
- information that state regulators report regarding disciplinary actions or allegations against representatives.

ALLEGED LIFE INSURANCE AS INVESTMENT AND NO TAX CONSEQUENCES. THE INSURED DID NOT ALLEGE ANY SPECIFIED DAMAGES HOWEVER, THE COMPANY'S GOOD FAITH DETERMINATION ESTIMATED THEM TO BE APPROXIMATELY \$7538.75. THIS POLICY WAS INITIALLY SOLD TO ALLOW THE INSURED TO TAKE HIS "SINGLE LIFE" PENSION OPTION WITH HIS EMPLOYER AND STILL HAVE HIS WIFE PROVIDED FOR IF HE SHOULD PREDECEASE HER. IT WAS NEVER INDICATED THAT THE ABBREVIATED PAY OPTION WAS A GUARANTEED BENEFIT OF THIS PLAN. MR. AND MRS. STENZEL KNEW THAT IT WAS DEPENDENT ON THE PERFORMANCE OF THE FUNDS IN THEIR POLICY. MR STENZEL HAD MANY OTHER EQUITY INVESTMENTS AT THE TIME AND WAS VERY WELL AWARE OF HOW THIS PRODUCT WORKED. IT WAS NOT SOLD AS AN INVESTMENT, BUT AS A LIFE INSURANCE POLICY. IN ADDITION, MR. STENZEL HAD THE OPPORTUNITY TO RECEIVE ALL OF HIS MONEY BACK UNDER THE CLASS ACTION LAW SUIT AGAINST PRUDENTIAL A FEW YEARS AGO AND HE CHOSE NOT TO MAKE A CLAIM OR COMPLAINT AT THAT TIME.
