WHEN ARRANGEMENTS WERE MADE TO COMPLETE THE PROPOSED TRANSACTION THE REPRESENTATIVE INFORMED THE CUSTOMER HIS FUNDS WERE NOT ELIGIBLE FOR THE INTENDED PRODUCT.
