IAPD offers information on all current-and many former representatives. Investors are strongly encouraged to use IAPD to check the background of representatives before deciding to conduct, or continue to conduct, business with them.

What is included in a IAPD report?

IAPD reports for individual representatives include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards.

It is important to note that the information contained in an IAPD report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the representative, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

Where did this information come from?

The information contained in IAPD comes from the Investment Adviser Registration Depository (IARD) and FINRA's Central Registration Depository, or CRD, (see more on CRD below) and is a combination of:

- information the states require representatives and firms to submit as part of the registration and licensing process, and
- information that state regulators report regarding disciplinary actions or allegations against representatives.

Allegations: [customer] alleged that he asked Cindy to invest his 401k in oil stock in 1999 then switched the investment while moving the oil stock to her name. Cindy did not meet [customer] until 2001 when he rolled over his 401k into a variable annuity. We were contacted by the State of Missouri on 11-12-15 that a consumer complaint had been made by [REDACTED]. We provided the state of MO with the signed VA application and the signed delivery receipt for the VA. Also I explained to the Investigator that we do not do that kind of investing therefore this was not possible with us. An email was received from the State on April 29th indicating that the case was close and there was no action taken.
