IAPD Information About Representatives

IAPD offers information on all current-and many former representatives. Investors are strongly encouraged to use IAPD to check the background of representatives before deciding to conduct, or continue to conduct, business with them.

What is included in a IAPD report?

IAPD reports for individual representatives include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards.

It is important to note that the information contained in an IAPD report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the representative, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

Where did this information come from?

The information contained in IAPD comes from the Investment Adviser Registration Depository (IARD) and FINRA's Central Registration Depository, or CRD, (see more on CRD below) and is a combination of:

- information the states require representatives and firms to submit as part of the registration and licensing process, and
- information that state regulators report regarding disciplinary actions or allegations against representatives.

Generally, representatives are required to update their professional and disciplinary information in IARD within 30 days.

The client ignores the 30-year history of the account, and even the very positive rate of return the account experienced despite the loss from the position in question. The matter was entirely frivolous. Nonetheless, in lieu of the cost of defending this matter and the distraction it would cause to my business, I reimbursed the client a portion of the advisory fees she had paid.

Broker Statement The investment in question was a very small piece of the client's overall portfolio. At the time of purchase she signed a disclosure form acknowledging, among other things, that she received a prospectus, and that the investment was illiquid. Additionally, the client's damages calculation fails to account for approximate \$4,000 in dividends she received. The investment is still ongoing.
