What is included in a IAPD report?

IAPD reports for individual representatives include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards.

It is important to note that the information contained in an IAPD report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the representative, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

Where did this information come from?

The information contained in IAPD comes from the Investment Adviser Registration Depository (IARD) and FINRA's Central Registration Depository, or CRD, (see more on CRD below) and is a combination of:

- information the states require representatives and firms to submit as part of the registration and licensing process, and
- information that state regulators report regarding disciplinary actions or allegations against representatives.

Broker Statement The allegations at issue are clearly erroneous and false. I was not involved in the alleged sales practice violations of breaches of fiduciary duty set out in the Statement of Claim, which was filed by the son of this customer, who is also a lawyer, and asserts claims and/or information that are clearly false. Toward those ends, the transactions at issue were the result of a third-party influence which I was not a part of and had no knowledge was occurring. Indeed, the customer



specifically declined to discuss the reason for these transactions when asked about the situation. The customer's instructions and identity were verified before each transaction, and the funds were liquidated and then deposited in a bank account for the customer and attached to the investment account for many years. Neither I, nor anyone associated with me, had any involvement with the transfer of funds out of that bank account held at an independent financial institution. I intend to vigorously defend these unfounded allegations.
