[CUSTOMER] HAS INVESTMENT EXPERIENCE AND IS FAIRLY KNOWLEDGEABLE ABOUT THE MARKET. HE TRANSFERRED HIS IRA TO ME AT WELLS FARGO ADVISORS FROM MERRILL. HE WAS TAKING \$400 PER MONTH FROM HIS IRA. THE ACCOUNT VALUE WAS APPROXIMATELY \$54,000 AT THE TIME. HE WAS STEADFAST IN REFUSING TO ADJUST THE AMOUNT HE WAS TAKING EACH MONTH. HE ALSO WANTED TO REMAIN CONSERVATIVE. WE HAD A LENGTHY DISCUSSION REGARDING THE FACT THAT IN THE CURRENT INTEREST RATE ENVIRONMENT THERE WAS NO WAY THAT HE COULD EARN ENOUGH INTEREST TO COVER THE MONTHLY DISTRIBUTION AND THAT HE WOULD HAVE TO DRAW ON PRINCIPAL THROUGHOUT THE YEAR, EVENTUALLY ENDING AT ZERO.

I SUGGESTED USING THE UNIT INVESTMENT TRUST CALLED THE HIGH FIFTY. THE HIGH FIFTY AT THE TIME HAD A 5.5% YIELD AND IS A VERY LIQUID INVESTMENT. THE HIGH FIFTY INVESTS IN THE FIFTY HIGHEST YIELDING STOCKS ON THE EXCHANGES. I EXPLAINED THAT BY USING DIVIDENDS AND A BIT OF PRINCIPAL OVER TIME THAT FUTURE GROWTH FROM THE STOCKS COULD MAKE THE ACCOUNT VALUE LAST LONGER THAN IF WE USED FIXED INCOME SECURITIES. THE HIGHER OVERALL RETURN SHOULD MAKE IT LAST LONGER. WE DISCUSSED THESE PARTICULARS FOR A WHILE AND I MADE IT CLEAR THAT SINCE WE WERE INVESTING IN STOCKS, THERE WOULD BE VOLATILITY WITH THE INVESTMENT.

[CUSTOMER] WAS SATISFIED WITH THE RECOMMENDATION AND AGREED TO INVEST IN THE HIGH FIFTY.
