What is included in a IAPD report?

IAPD reports for individual representatives include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards.

It is important to note that the information contained in an IAPD report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the representative, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

Where did this information come from?

The information contained in IAPD comes from the Investment Adviser Registration Depository (IARD) and FINRA's Central Registration Depository, or CRD, (see more on CRD below) and is a combination of:

- information the states require representatives and firms to submit as part of the registration and licensing process, and
- information that state regulators report regarding disciplinary actions or allegations against representatives.

Broker Statement CUSTOMER'S, IRA WAS RECEIVED AS A TRANSFER FROM A FIXED INTEREST BANK IRA ON 1/24/98 AND WAS DEPOSITED INTO A METLIFE PREFERENCE PLUS ACCT IRA WITH 80% REMAINING IN FIXED INTEREST BASED ON HIS RISK TOLERANCE AT THAT TIME. ON AROUND 2/12/97, CUSTOMER CONTACTED NOELINE WHITE AT METLIFE IN DENVER AFTER A PHONE CONVERSATION THAT WE HAD REGARDING A MAGAZINE ARTICLE THAT PORTRAYED ANNUITIES IN A NEGATIVE LIGHT IN THE FALL OF 1996.



HE ASKED MS. WHITE TO WAIVE SURRENDER CHARGES (AROUND \$160) ON HIS CONTRACT. HE THEN FOLLOWED UP WITH A LETTER TO ME CITING HIS CONCERNS FOLLOWING THE MAGAZINE ARTICLE. I NOTIFIED HIM IN WRITING IN FEB 1997 THAT HE WOULD NEED TO CONTACT WARREN BERG AT METLIFE IN DENVER TO REQUEST THAT THE SURRENDER CHARGES BE WAIVED. IT APPEARS THAT HE DID NOT PROCEED WITH CONTACTING MR. BERG AND TO THIS DATE, HIS IRA ACCOUNT HAS REMAINED INTACT. IN MY OPINION, CUSTOMER REQUESTED FOR \$7700+ IS UNSUBSTANTIATED AND EXCESSIVE AND BASED ON INACCURATE INFORMATION. AS SETTLEMENT WITH THE CLIENT, THE COMPANY CREDITED \$700 TO HIS VARIABLE ANNUITY WITH AN EFFECTIVE DATE OF 2/2/01.
