PENSION CONSULTANTS, INC., BRIAN ALLEN AND CHRISTOPHER THIXTON BELIEVED IN GOOD FAITH (AS STIPULATED TO IN THE CONSENT ORDER ISSUED BY THE MISSOURI DIVISION OF SECURITIES), UPON ASSURANCE OF COUNSEL, THAT BRIAN ALLEN AND CHRISTOPHER THIXTON WERE SUCCESSFULLY REGISTERED AS INVESTMENT ADVISOR REPRESENTATIVES IN MISSOURI. AS SOON AS PENSION CONSULTANTS, INC., BRIAN ALLEN AND CHRISTOPHER THIXTON BECAME AWARE THAT SUCH REGISTRATIONS WERE DEFICIENT, EACH PARTY TOOK STEPS TO SELF-REPORT AND BRING THEMSELVES INTO COMPLIANCE WITH MISSOURI LAW.
