What is included in a IAPD report?

IAPD reports for individual representatives include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards.

It is important to note that the information contained in an IAPD report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the representative, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

Where did this information come from?

The information contained in IAPD comes from the Investment Adviser Registration Depository (IARD) and FINRA's Central Registration Depository, or CRD, (see more on CRD below) and is a combination of:

- information the states require representatives and firms to submit as part of the registration and licensing process, and
- information that state regulators report regarding disciplinary actions or allegations against representatives.

Generally, representatives are required to update their professional and disciplinary information in IARD within 30 days.

MILES, [THIRD PARTY], AND BENEFICIAL LIFE INSURANCE CO., DEFENDANTS, (CASE # 960700371) IN THE SECOND JUDICIAL DISTRICT COURT IN DAVIS COUNTY, STATE OF UTAH. IN APRIL 1989, THE PARENTS OF THE PLAINTIFFS (THE DAUGHTERS) HELD TWO ACCOUNTS WITH EACH ACCOUNT WORTH APPROXIMATELY \$27,809.61 TITLED IN JOINT TENANCY WITH EACH DAUGHTER. ON APRIL 25, 1989, ALL MONEYS FROM THE JOINT TENANCY ACCOUNTS WERE TRANSFERRED INTO VARIOUS BENEFICIAL LIFE POLICIES FOR THE BENEFIT/OWNERSHIP OF ONLY THE PARENTS. THE DAUGHTERS ALLEGED THAT THEIR PURPORTED SIGNATURES ON THE REDEMPTION REQUEST FORM WERE NOT THEIR ACTUAL SIGNATURES AND INSTEAD SIGNED BY LEE MILES OR [THIRD PARTY]. THE CASE WAS SETTLED FOR \$37,500 BY THE DEFENDANTS ON 12/13/1999 AND A STIPULATION FOR DISMISSAL WITH PREJUDICE WAS FILED WITH THE WEBER COUNTY, SECOND JUDICIAL COURT (UNDER CASE # 970902852) ON JANUARY 18, 2000 AND WAS DISMISSED WITH PREJUDICE AS TO ALL PARTIES.
