## IAPD Information About Representatives

IAPD offers information on all current-and many former representatives. Investors are strongly encouraged to use IAPD to check the background of representatives before deciding to conduct, or continue to conduct, business with them.

### What is included in a IAPD report?

IAPD reports for individual representatives include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards.

It is important to note that the information contained in an IAPD report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the representative, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

### Where did this information come from?

The information contained in IAPD comes from the Investment Adviser Registration Depository (IARD) and FINRA's Central Registration Depository, or CRD, (see more on CRD below) and is a combination of:

- information the states require representatives and firms to submit as part of the registration and licensing process, and
- information that state regulators report regarding disciplinary actions or allegations against representatives.

THE ADJUSTABLE RATE PREFERRED SECURITIES RECOMMENDED BY SCOTT FERGUSON COMPRISED 3% OF A WELL DIVERSIFIED PORTFOLIO. THE INVESTOR TERMINATED HIS BROKERAGE ACCOUNT AND MOVED TO ANOTHER FINANCIAL ADVISOR. THE FINANCIAL ADVISOR AND THE FORMER CLIENT HAD 5 MONTHS IN WHICH TO LIQUIDATE THE PREFERRED. IT WAS ONLY AFTER THE PREFERRED AUCTIONS BROKE DOWN IN 2008 DID THE FORMER CLIENT REQUEST RESCISSION OF THEIR INVESTMENT IN THE ADJUSTABLE PREFERRED SECURITIES. \$25,000 OF THE PREFERRED WERE CALLED AT FACE VALUE AND THE BALANCE (\$75,000) WERE PURCHASED BACK BY DA DAVIDSON. THE BALANCE (\$75,000) WERE LATER CALLED AT FACE VALUE BY THE ISSUER. SCOTT FERGUSON DID NOT PARTICIPATE IN OR CONTRIBUTE FUNDS TO THIS SETTLEMENT. THIS SETTLEMENT IS NOT TO BE CONSTRUED AS AN ASSESSMENT OF THE MERITS OF THE COMPLAINT, AS AN ACKNOWLEDGEMENT OF THE VALIDITY OF THE COMPLAINT, OR AS AN ADMISSION OF LIABILITY WITH RESPECT TO THE COMPLAINT.
