What is included in a IAPD report?

IAPD reports for individual representatives include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards.

It is important to note that the information contained in an IAPD report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the representative, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

Where did this information come from?

The information contained in IAPD comes from the Investment Adviser Registration Depository (IARD) and FINRA's Central Registration Depository, or CRD, (see more on CRD below) and is a combination of:

- information the states require representatives and firms to submit as part of the registration and licensing process, and
- information that state regulators report regarding disciplinary actions or allegations against representatives.

Generally, representatives are required to update their professional and disciplinary information in IARD within 30 days.

On the evening of September 13th, 2019, I meet with both clients at their home for over 2 hours reviewing all of their investments. Their total household value at the time held at Ameriprise was \$458,719. They were over 80% in Equities at that time and had a profit on the year of \$92,979. I recommended they sell several Mutual Funds to lock in those gains and reduce their Equity exposure. They were more than willing to make the changes and didn't realize they were that exposed in Equities. At the same time, the client logged into his 401K and made similar changes to reduce his Equity position to 50%.
