The allegations made by this client were due to the stock and bond markets falling in value in 2022. Most of any well diversified portfolios of stocks and bonds - declined in value in 2022. I believe that I acted, prudent, professionally and in the best interest and well-being of this client during their long wealth management relationship and determined any fees the client was charged were appropriate relative to the extensive wealth management services they provided to this client.

It is regrettable this case was filed after nearly ten years of providing the client with extensive wealth management and financial planning services. I vigorously disputed the meritless allegations by this former client. Ultimately, Wells Fargo and Raymond James made the decision to settle the matter to avoid the cost and distraction of litigation and I was not asked to pay for, share, or contribute in any part to the settlement or the associated.

The settlement total of \$95,000 is comprised of a \$30,000 contribution by Wells Fargo and a \$65,000 contribution by Raymond James.
