IAPD offers information on all current-and many former representatives. Investors are strongly encouraged to use IAPD to check the background of representatives before deciding to conduct, or continue to conduct, business with them.

What is included in a IAPD report?

IAPD reports for individual representatives include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards.

It is important to note that the information contained in an IAPD report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the representative, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

Where did this information come from?

The information contained in IAPD comes from the Investment Adviser Registration Depository (IARD) and FINRA's Central Registration Depository, or CRD, (see more on CRD below) and is a combination of:

- information the states require representatives and firms to submit as part of the registration and licensing process, and
- information that state regulators report regarding disciplinary actions or allegations against representatives.

Generally, representatives are required to update their professional and disciplinary information in IARD within 30 days.

 - A "resolved" matter usually includes a disposition wherein no payment is made to the customer or there is no finding of wrongdoing on the part of the Investment Adviser Representative. Such matters generally involve customer disputes.

Broker Statement

MERRILL LYNCH AGREED TO PAY CLAIMANT LUDWIG CORPORATION \$45,000 IN EXCHANGE FOR A GENERAL RELEASE. CLAIMANT INITIALLY PURCHASED CURRENCY OPTIONS TO HEDGE A POSITION IN BRITISH BONDS. THEREAFTER, IT BEGAN TO SPECULATE IN CURRENCY OPTIONS. APPROXIMATELY THREE MONTH BEFORE TRADING CEASED, THE CUSTOMER'S PRINCIPAL, [PRINCIPAL], MET WITH THE BRANCH MANAGER AND EXPRESSED COMPLETE SATISFACTION WITH THE ACCOUNT. FURTHERMORE, [PRINCIPAL'S] SON, A CURRENCY TRADER AT CHEMICAL BANK, RECEIVED COPIES OF ALL CONFIRMATIONS AND STATEMENTS, AND VOICED NO OBJECTION. THE DECISION TO SETTLE WAS BASED UPON THE COSTS AND UNCERTAINTY OF FURTHER LITIGATION.
