My client voluntarily dismissed the allegations. I recommended the investment in good faith. It was approved by my broker-dealer, and suitable based on the disclosed investment objectives and risk tolerance. The client was fully informed about all material risks and features of the investment, and he purchased it only after acknowledging that he understood and accepted those risks. The investment was well within the concentration limits, and as a salaried employee, I did not receive any commission from the purchase. At all times, I put my client's interest first, and there was no merit to the arbitration, as is evident from its ultimate dismissal.
