IAPD offers information on all current-and many former representatives. Investors are strongly encouraged to use IAPD to check the background of representatives before deciding to conduct, or continue to conduct, business with them.

What is included in a IAPD report?

IAPD reports for individual representatives include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards.

It is important to note that the information contained in an IAPD report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the representative, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

Where did this information come from?

The information contained in IAPD comes from the Investment Adviser Registration Depository (IARD) and FINRA's Central Registration Depository, or CRD, (see more on CRD below) and is a combination of:

- information the states require representatives and firms to submit as part of the registration and licensing process, and
- information that state regulators report regarding disciplinary actions or allegations against representatives.

How current is this information?

Generally, representatives are required to update their professional and disciplinary information in IARD within 30 days.

 - A "settled" matter generally represents a disposition wherein the parties involved in a dispute reach an agreement to resolve the matter. Please note that Investment Adviser Representatives and firms may choose to settle customer disputes or regulatory matters for business or other reasons.
 - A "resolved" matter usually includes a disposition wherein no payment is made to the customer or there is no finding of wrongdoing on the part of the Investment Adviser Representative. Such matters generally involve customer disputes.

This section provides information regarding a customer dispute that was reported to the Investment Adviser Registration Depository (IARD) by the Investment Adviser Representative (IAR), an investment adviser and/or securities firm, and/or a securities regulator. Reporting Source: Individual

Employing firm when activities occurred which led to the complaint: MORGAN STANLEY & CO., INC.

Allegations: CUSTOMER ORALLY ALLEGED THAT IN AUGUST 2007, HE PLACED A LIMIT ORDER TO PURCHASE APPLE STOCK WITH ONE SALES ASSISTANT AND THAT LATER THE SAME DAY A DIFFERENT SALES ASSISTANT TOLD HIM THAT THE ORDER HAD BEEN FILLED. IT TURNED OUT THE ORDER WAS NOT FILLED AND THE CONTRARY INFORMATION ALLEGEDLY PROVIDED TO THE CUSTOMER WAS INCORRECT. IN ALLEGED RELIANCE ON THIS INCORRECT INFORMATION, THE CUSTOMER CLAIMED THAT HE SUBMITTED AN ORDER TO SELL APPLE SHARES HE HE HAD PURCHASED THROUGH HIS LIMIT ORDER. THE CUSTOMER FURTHER CLAIMED THAT, BUT FOR HIS RECEIPT OF INFORMATION THAT HIS LIMIT ORDER HAD BEEN FILLED, HE WOULD NOT HAVE SUBMITTED AN ORDER TO SELL APPLE SHARES. THE CUSTOMER'S SELL ORDER RESULTED IN THE CUSTOMER LIQUIDATING UNRELATED APPLE SHARES HE HAD PURCHASED APPROXIMATELY ONE WEEK EARLIER. THE CUSTOMER CLAIMED THAT HE DID NOT INTEND TO SELL THESE SHARES AND THAT THIS SALE RESULTED IN ALLEGED LOSSES.
