IAPD offers information on all current-and many former representatives. Investors are strongly encouraged to use IAPD to check the background of representatives before deciding to conduct, or continue to conduct, business with them.

What is included in a IAPD report?

IAPD reports for individual representatives include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards.

It is important to note that the information contained in an IAPD report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the representative, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

Where did this information come from?

The information contained in IAPD comes from the Investment Adviser Registration Depository (IARD) and FINRA's Central Registration Depository, or CRD, (see more on CRD below) and is a combination of:

- information the states require representatives and firms to submit as part of the registration and licensing process, and
- information that state regulators report regarding disciplinary actions or allegations against representatives.

How current is this information?

Generally, representatives are required to update their professional and disciplinary information in IARD within 30 days.

 - A "resolved" matter usually includes a disposition wherein no payment is made to the customer or there is no finding of wrongdoing on the part of the Investment Adviser Representative. Such matters generally involve customer disputes.

THE CLIENTS ALSO STATE MAZZOTTI INFORMED THEM THERE WOULD BE NO CHARGE ON THE SALE OF THE MUTUAL FUNDS, WHOSE PROCEEDS WERE USED TO PURCHASE THE ANNUITY.

Broker Statement

MAZZOTTI STATES THE CLIENTS WERE LOOKING FOR REGULAR PAYMENTS AND WERE INTERESTED IN MINIMIZING TAXES. MAZZOTTI INDICATES HE REVIEWED SEVERAL OPTIONS WITH THE CLIENTS, HOWEVER, THE EVENTUALLY CHOSE THE VARIABLE ANNUITY. MAZZOTTI STATES HE DISCLOSED THE CDSC CHARGES, THE SURRENDER PERIOD AND THAT DISTRIBUTIONS COULD BE WITHDRAWN UP TO 10% PER YEAR. WHEN THE ANNUITY WAS PURCHASED THE CLIENTS RECEIVED A COPY OF THE ANNUITY CONTRACT INDICATED THE 10 DAY FREE LOOK PERIOD. IN ADDITION, THE CLIENTS RECEIVED NUMEROUS EDWARD JONES STATEMENTS WHICH REFLECTED THE VALUE OF THE FIXED ACCOUNT AND THE MARKET FLUCTUATION OF THE VARIABLE ACCOUNTS. CLAIM DENIED.
