What is included in a IAPD report?

IAPD reports for individual representatives include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards.

It is important to note that the information contained in an IAPD report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the representative, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

Where did this information come from?

The information contained in IAPD comes from the Investment Adviser Registration Depository (IARD) and FINRA's Central Registration Depository, or CRD, (see more on CRD below) and is a combination of:

- information the states require representatives and firms to submit as part of the registration and licensing process, and
- information that state regulators report regarding disciplinary actions or allegations against representatives.

Generally, representatives are required to update their professional and disciplinary information in IARD within 30 days.

I REVIEWED THE ANNUITY TRANSACTION IN QUESTION AND CONTACTED IR, MR. BRUCE BIEDAR. IR STATED HE MET WITH CLIENT TO REVIEW HER ACCOUNT AT LEAST TWICE A YEAR SINCE 1997. INCLUDED IN THESE REVIEWS WERE VARIOUS FIXED ANNUITIES HELD OUTSIDE OF EDWARD JONES. IR STATED HE ROUTINELY ADVISED CLIENT TO LEAVE THESE ANNUITIES AS THE FIXED RATE WAS RELATIVELY GOOD AND THE SURRENDER FEES WERE TOO HIGH. IN JUNE, 2001, IR STATED HE DID RECOMMEND MOVING CLIENTS ING FIXED ANNUITY TO A HARTFORD VARIABLE ANNUITY AS THE FIXED RATE WAS DROPPING AND THE SURRENDER FEE WAS DOWN. IR STATED HE BELIEVED THE RECOMMENDATION OF THE VARIABLE ANNUITY FURTHER FIT CLIENT'S BALANCED INVESTMENT OBJECTIVE. IR STATED CLIENT WAS FULLY AWARE OF THE SURRENDER FEE ASSOCIATED WITH ING FIXED ANNUITY. ACCORDING TO IR HE DISCUSSED IN DETAIL THE HARTFORD VARIABLE ANNUITY TO INCLUDE THE 7 YEAR CONTINGENT DEFERRED SALES CHARGE (CDSC), THE 15% ANNUAL WITHDRAWAL AND AVAILABLE SUBACCOUNTS. IR STATED HE DISCUSSED IN DETAIL (PROVIDING CLIENT WITH THE PROSPECTUS) THE SUBACCOUNTS AVAILABLE AND RECOMMENDED FOUR (4) SUBACCOUNTS AND CLIENT WAS INFORMED THE VALUE OF THESE SUBACCOUNTS COULD FLUCTUATE. IR FURTHER STATED HE RECOMMENDED THE ONE (1) YEAR DCA PROGRAM. IN ADDITION TO THE INFORMATION PROVIDED TO CLIENT BY IR, THE PROSPECTUS AND CONTRACT FURTHER DISCLOSE ALL FEATURES OF THE ANNUITY CONTRACT AS WELL AS THE VARIOUS SUBACCOUNTS AND THE ASSOCIATED RISKS. CLIENT SIGNED THE ANNUITY CONFIRMATION/DELIVERY RECEIPT VERIFYING HER RECEIPT OF THE ANNUITY CONTRACT. THE ANNUITY INVESTMENT WOULD HAVE ADDITIONALLY BEEN REPORTED ON CLIENT'S EDWARD JONES CUSTOMER ACCOUNT STATEMENTS FROM THE TIME OF PURCHASE. IT DOES APPEAR THE ANNUITY PURCHASE WAS DONE WITH THE CLIENT'S KNOWLEDGE AND AUTHORIZATION. CLAIM DENIED
