Where did this information come from?

Allegations: Without admitting or denying the findings, Chen consented to the sanctions and to the entry of findings that his member firm, though Chen, failed to supervise the investment-advisory activities of a registered representative. The findings stated that Chen and the firm permitted a registered representative to engage in investment-advisory activity away from the firm through his state-registered investment advisor. The findings also stated that the registered representative, in his capacity as an investment advisor representative, caused securities transactions to be executed on behalf of his investment advisor clients away from the firm. Chen was the principal responsible for supervision of the registered representative. The firm, through Chen, failed to supervise the registered representative's business in any manner because Chen failed to recognize that the registered representative's activities constituted private securities transactions.
