### Where did this information come from?

The information contained in IAPD comes from the Investment Adviser Registration Depository (IARD) and FINRA's Central Registration Depository, or CRD, (see more on CRD below) and is a combination of:

- information the states require representatives and firms to submit as part of the registration and licensing process, and

This section provides information regarding a customer dispute that was reported to the Investment Adviser Registration Depository (IARD) by the Investment Adviser Representative (IAR), an investment adviser and/or securities firm, and/or a securities regulator. **Employing firm when activities occurred which led to the complaint:** EDWARD JONES

**Allegations:** THE CLIENT STATES THAT HE EXPLAINED TO THE IR WHEN THE ACCOUNT WAS OPENED IN 1999 (MARCH) THAT HE WAS DEPENDING ON THE FUNDS FOR MOST OF HIS RETIREMENT INCOME AND DID NOT WANT TO EXPOSE THE FUNDS TO UNDO RISK. THE CLIENT STATES THAT HIS INVESTMENTS WERE MOSTLY IN GROWTH AND GROWTH/INCOME SECTORS AND HE FEELS THIS WAS TOO AGGRESSIVE. THE CLIENT STATES THAT THE IR EXPLAINED THE FUNDS THE CLIENT OWNED WERE NOT AGGRESSIVE FUNDS. THE CLIENT EVENTUALLY TRANSFERRED HIS ACCOUNT TO ANOTHER FIRM. THE CLIENT STATES THAT THE ALLOCATION OF HIS INVESTMENTS DID NOT CHANGE DURING THE TIME THE ACCOUNT WAS WITH EDWARD JONES AND GIVEN THE MARKET CONDITIONS AND THE NEED FOR RETIREMENT INCOME THIS WAS "NOTHING SHORT OF NEGLIGENT". THE CLIENT IS CLAIMING THAT HIS ACCOUNT SHOULD BE WORTH \$280,000-\$300,00 AND THE VALUE WAS APPROXIMATELY \$117,105 AT THE TIME OF TRANSFER. THE CLIENT FEELS HE SHOULD BE COMPENSATED FOR THE DIFFERENCE.

THE IR STATED THAT IN 1999 HE DISCUSSED OWNING MUTUAL FUNDS WITH THE CLIENT AND THE FACT THAT THERE IS A DEGREE OF RISK ASSOCIATED WITH INVESTING. HE ALSO DISCUSSED HOW TAKING WITHDRAWALS FROM THE FUNDS WOULD AFFECT THE VALUE OF THE ACCOUNT. BASED ON THE OBJECTIVES OF THE CLIENT, IT WAS RECOMMENDED THE HE INVEST IN INCOME FUNDS, GROWTH AND INCOME FUNDS AND GROWTH FUNDS. THE CLIENT AGREED WITH THE RECOMMENDATIONS AND THE TRADES WERE PLACED. THE IR STATED THAT THE CLIENT INDICATED HE WOULD NOT NEED INCOME FROM HIS INVESTMENTS FOR A WHILE, HOWEVER, THE MONTH FOLLOWING THE TRADES HE BEGAN TAKING WITHDRAWALS. THE IR RECALLED, ON MORE THAN ONE OCCASION, EXPRESSING HIS CONCERN OVER THE NUMEROUS WITHDRAWALS. IT APPEARS AS THOUGH THE INVESTMENTS WERE NOT INAPPROPRIATE AT THE TIME AND ANY DECLINE EXPERIENCED WITH THE FUNDS IS ATTRIBUTED TO MARKET FLUCTUATION WHICH IS A RISK ASSOCIATED WITH INVESTING. CLAIM DENIED.
