What is included in a IAPD report?

IAPD reports for individual representatives include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards.

It is important to note that the information contained in an IAPD report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the representative, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

Where did this information come from?

The information contained in IAPD comes from the Investment Adviser Registration Depository (IARD) and FINRA's Central Registration Depository, or CRD, (see more on CRD below) and is a combination of:

- information the states require representatives and firms to submit as part of the registration and licensing process, and
- information that state regulators report regarding disciplinary actions or allegations against representatives.

Broker Statement

In 2023 and 2024, I sought to support women, particularly those navigating divorce or loss, through mindset-based financial coaching. I submitted a formal Outside Business Activity (OBA) request in April 2024 under the business name Monarch Mindset. This OBA request was reviewed and approved by Raymond James, with stipulations that I maintain separation from Raymond James activities, not reference the firm, and notify them if the activity became revenue-generating. I abided by all conditions, did not earn income from the course, and did not mention Raymond James on social media or in program content. Despite full compliance, I was placed on administrative leave and subsequently



terminated in September 2024, with the firm citing the OBA as the reason. I strongly disagreed with this decision given the prior written approval. After a formal investigation by FINRA, the case was closed with no findings of wrongdoing. I am proud to have maintained an unblemished record for over 25 years as a licensed financial professional and remain committed to serving my clients with integrity and transparency.
