IAPD offers information on all current-and many former representatives. Investors are strongly encouraged to use IAPD to check the background of representatives before deciding to conduct, or continue to conduct, business with them.

What is included in a IAPD report?

IAPD reports for individual representatives include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards.

It is important to note that the information contained in an IAPD report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the representative, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

Where did this information come from?

The information contained in IAPD comes from the Investment Adviser Registration Depository (IARD) and FINRA's Central Registration Depository, or CRD, (see more on CRD below) and is a combination of:

- information the states require representatives and firms to submit as part of the registration and licensing process, and
- information that state regulators report regarding disciplinary actions or allegations against representatives.

Allegations: Without admitting or denying the findings, Nahrstedt consented to the sanctions and to the entry of findings that he submitted a false attestation to his member firm and caused the firm to maintain inaccurate books and records. The findings stated that the firm received an email from an individual posing as a firm customer. The email requested a \$500,000 wire transfer from the customer's account to a bank in Mexico for the purported purpose of purchasing an apartment there. Unbeknownst to the firm, an imposter had sent the email to the firm without the customer's authorization. To initiate the wire transfer request, Nahrstedt signed a "Change of Ownership" form in which he falsely attested that he had spoken with the customer in connection with the requested wire transfer, as was required by firm policy. In fact, Nahrstedt had not spoken with the customer concerning the wire transfer. As a result of Nahrstedt's false statement, the firm processed the \$500,000 wire transfer from the customer's account to an unknown third party.
